Register your coworkers via the [NAACCR 2026 Virtual Conference webpage](#) or your [MyNAACCR](#) account. All registrants will need to have an active MyNAACCR account affiliated with your organization.

This registration is for one person to view the NAACCR 2026 Virtual Conference content live during presentation on June 23, 24, and 25. Recordings will also be posted and available to the registered participant for viewing after the virtual conference.

Sharing login details, viewing by unregistered persons, and/or the sharing of recorded content post-conference with unregistered persons is prohibited. Failure to comply with any of the above conditions will result in access to the platform being denied. No refund will be issued. Certificates of Participation and CEUs will only be awarded to registered participants.

Login details for the NAACCR 2026 Virtual Conference platform will only be provided to attendees who have paid for their registration in full or have made alternate arrangements with the NAACCR office. Login details will be sent approximately one week prior to the start of the virtual conference.
